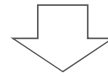

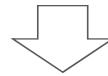

Art: we give artists the possibility to show and promote their sculptures and paintings in our offices to our international clients.

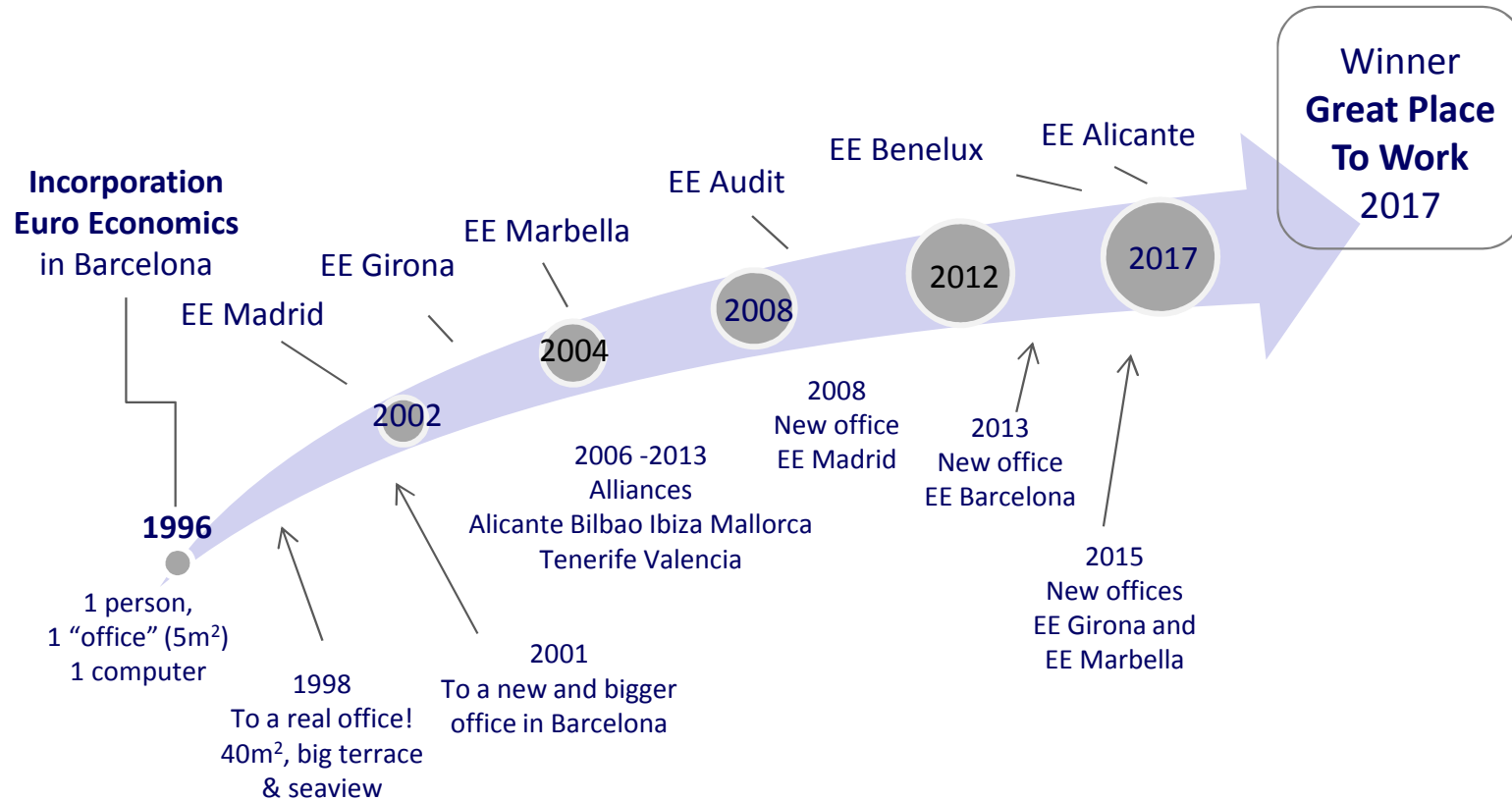
Culture: we sponsor the Dutch Kings Day in Barcelona.
